**TUITION POLICIES & PAYMENT PROCEDURES**

- We accept Cash, Check, Visa and Mastercard
- First months tuition is due upon registration. Subsequent month's tuition is due the first of each month through the month of June. Studio closings for holidays are built into our pricing structure.
- All tuition payments are due the first of each month
- Accounts are given a seven (7) day grace period after which time a \$35 late fee will be added to your account.
- If an account is 45 days past due, your dancer will no longer be allowed to participate in any classes or events at CFDC until the account is made current. There will be no deduction in tuition for students unable to attend classes due to an outstanding balance.
- Your account will be assessed a \$70 fee for Returned Checks. This is the \$35 NSF fee for the returned check, as well as the \$35 late fee.
- There is no tuition reduction for missed or cancelled classes. Classes missed due to illness may be made up when the student is feeling better. Class cancellations due to inclement weather can be made up in comparable classes during the week. Please ask a CFDC staff member for make-up class recommendations.

**Medical Release & Waiver/Photo & Video Release**
